

**RESOLUTION DESIGNATING DIABLO VALLEY COLLEGE
AS AN ALTERNATE COUNTY SEAT FOR CONTRA COSTA COUNTY
IN THE EVENT OF A PUBLIC EMERGENCY
CONTRA COSTA COMMUNITY COLLEGE DISTRICT, CALIFORNIA**

SUBJECT: In the matter of serving as an alternate) **Resolution No. 23-A**
 County seat for Contra Costa County)
 in the event of a public emergency)

WHEREAS Government Code section 23600 provides that a board of supervisors shall designate by resolution an alternative temporary county seat for use in the event of war or enemy-caused disaster, or the imminence thereof; and

WHEREAS the board, and any county officer or agency as directed by the board, shall provide such facilities of any kind at the temporary county seat as appear desirable for the functioning of the government of the county at the temporary county seat in the event that it becomes necessary; and

WHEREAS it is in the public's interest to identify alternate locations both within and without Contra Costa County, in anticipation that a local emergency makes Contra Costa County facilities in Martinez inaccessible; and

WHEREAS the Contra Costa County Board of Supervisors would require a public meeting room that seats 200 individuals, has a public address system, is accessible under the Americans with Disabilities Act, and has adequate parking facilities; and

WHEREAS the Contra Costa County Board of Supervisors, on September 14, 2010, adopted Resolution No. 2010/458 designating Diablo Valley College as a temporary alternate county seat for Contra Costa County government;

NOW, THEREFORE, BE IT RESOLVED that the Governing Board of the Contra Costa Community College District hereby agrees to the designation of Diablo Valley College at 321 Golf Club Road in Pleasant Hill, California, as a temporary alternate county seat for Contra Costa County government in the event of war or enemy-caused disaster and directs the Chancellor's Office to file copies of this resolution with the Contra Costa County Board of Supervisors and the Contra Costa County Administrator's Office.
